

OFFICIAL RULES FOR DEVILBISS RACING T-SHIRT WITH TEKNA PURCHASE PROMOTION

The FREE DeVilbiss Racing T-Shirt with a TEKNA Spray Gun Promotion ("Promotion") begins July 15, 2015 and ends August 31, 2015 ("Promotion Period"). The promotion is sponsored by DeVilbiss Automotive Refinishing, 11360 S. Airfield Rd., Swanton OH 43558 ("Sponsor"). Void where prohibited.
